Please arrive 15 minutes prior to your start time of your event.

As we run a ticketless system the team will meet you at the location and have your details on the guest list, so you are not required to supply proof of purchase, you are more than welcome to print this and bring it with you if you wish

What you will need for the event:

A Torch as we will be working in the dark.

You are welcome to bring your camera/recording equipment if you wish for use during the event

Layered clothing and Flat gripped footwear. a waterproof coat and umbrella for use in the event of wet weather.

You are responsible for arriving at the stated time and the event will begin punctually.

After the first part of the walk there will be a short drive in convoy to Williamson Park.

Parking is local street parking and local car parks at Lancaster Castle & Williamson Park please check parking fees and times prior to leaving your car.

Haunting Nights Terms & Conditions
